

SHRIMP COCKTAIL

- 1 pound of medium size shrimps raw or cooked

- ¼ Cup Tito's Vodka rum



New Law Unleashes Insurance Company Dominance & Guts Consumer Rights

If you don't have a legal background, you probably are not aware that in March 2023 a recent bill was passed by the Florida legislature and signed into law. If you are in a car crash in Florida, your rights have been dramatically affected. Notably, insurance companies, known for seeking to minimize victim payouts, were among the biggest supporters of this law.

If you've been injured in an accident, it's important to understand three key provisions in the new law that affect your claim. To provide you with a clearer understanding of this tort reform, let's go over some basic information.

Three key points:

House Bill 837 has huge implications for car crash and personal injury victims:

1. Statute of Limitations - The statute of limitations in Florida has been reduced from four years to two years, giving plaintiffs a shorter time frame to file a lawsuit and risking complete loss of compensation if the deadline is missed.

2. Medical Bills – The new law imposes limits on the amount of

medical bills that can be recovered by accident victims.

3. Comparative Fault eliminated (almost) - In the past, victims could still receive monetary damages even if they were partially at fault for the accident.


a. Example - Let's say you were speeding, and someone ran a red light and hit you. If the jury finds you were 51% at fault you could still recover 49% of your damages. However, under the revised law, plaintiffs are barred from recovering any monetary damages if they were more than 50% responsible for the incident. The jury will determine the proportion of fault assigned to each party involved.

b. Example – You went out for a few beers and are technically over the legal limit. On your way home a motorist runs a red light, paralyzes you and you incur \$2,000,000 in medical bills. If the jury finds you were 51% at fault you get NOTHING, whereas under the old law you would have received \$1,000,000 for your medicals plus 49% of your pain and suffering.

This is not good news for the consumer!
