The Dangers of Garbage Trucks



Garbage trucks are big and heavy. They help keep our streets clean, but they can also be dangerous. Unlike semi-trucks, garbage trucks are often in residential areas. It is important to know the difference between the types of trucks and why they can cause accidents.

Both types of trucks can be dangerous. They have big blind spots. This means the driver may not see people walking nearby. They are also heavy and cannot stop quickly. If something goes wrong, the truck can cause a lot of damage. Always be careful around garbage trucks. Stay back and do not try to cross in front of them. Drivers may not see you. If you are driving, do not try to pass a garbage truck when it is stopping or turning. These trucks need a lot of room.

RECIPE OF THE MONTH

Anjali's Muffin Tin Chicken Pot Pies

- 1 batch of pie crust
- 1 lb boneless, skinless chicken breast, cubed
- ¾ cup each chopped carrots, potato, and green beans
- ½ cup corn (fresh or frozen)
- ½ cup each butter, chopped onion, and all-purpose flour
- ½ tsp salt, ¼ tsp black pepper, and optional spices (e.g., garlic, celery seed)
- 2 cups of chicken broth
- 1 to 1½ cups milk

PREPARATION

Preheat oven to 425°F (220°C)

Boil chicken, carrots, potatoes, and beans in enough chicken broth to cover for 15 mins. Drain (save broth), stir in corn, and set aside.

Sauté onions in butter until soft. Add flour, salt, pepper, and spices. Slowly stir in 1¾ cups broth and 1 cup milk. Simmer until thick.

Combine chicken mix and sauce. Add more broth/milk if needed for a gravy-like consistency.

Roll out dough into 12 circles (4 per ½ of dough). Press 6 into muffin tin cups with ½" overhang.

Fill generously with chicken mixture. Top with remaining dough circles.

Seal & vent: Pinch edges to seal and trim excess. Cut slits for steam.

Bake for 30 mins or until golden brown.


